Frequently Asked Questions

How does it work? Each month, your monthly association dues will be deducted from your designated U.S. bank account between the 5th and 10th of each month. Your bank statement will show the date and amount of each payment.

Does my bank participate? U.S. banks, savings & loans and credit unions that are members of the Automated Clearing House (ACH) are participating institutions.

What do I have to do to use Surepay? Complete the Authorization Form and return it to Maui Condo Services and we'll process your payment for you each month. Please ensure that sufficient funds are in your account by the 5th of each month so that the payment can be processed.

Is there a charge for using the SurePay service? No. However there will be service charges if your bank declines to process the SurePay payment for insufficient funds, etc.

Will other payments be made using SurePay? No. Special assessments, fines and other fees must be paid by check.

How do I terminate the SurePay service? Contact Maui Condo Services in writing prior to the last business day of the month and we'll stop your SurePay automatic payment plan for the following month.
